A. Effectivity

This Service Bulletin applies to Terrain Awareness and Warning System (TAWS), P/N 3010-0X-00 with SCN 12.X.

B. Compliance

Update of the TAWS Obstacle Database is optional.

C. Description

Obstacle Database updates are available for installation into TAWS Class A and B systems with SCN 12.0 and later. This database contains the latest obstacle features to increase the effectiveness of a TAWS installation.

The obstacle database is updated quarterly and field loadable by customers. This can be done with either a Universal Avionics FMS or personal computer with the Universal Serial Tool Program interfaced with either a DTU-100 or Solid State Data Transfer Unit (SSDTU).

Due to space limitations in the TAWS unit, the obstacle database is filtered to remove any obstacle with a height above ground less than 50 feet. The TAWS systems with the Obstacle Database is not intended to provide navigational guidance, except for warnings to avoid hazardous terrain and/or obstacles, nor to relieve aircrews from following published navigation procedures, routes, altitude restrictions, and/or instructions from appropriate air traffic control agencies.
